How do we store your data?

The platform is based on Microsoft Azure and we store your data in a database located in the northern Europe. The database is encrypted to ensure the integrity of your data.

We cannot, however, ensure or warrant the absolute security of any information you transmit to Digital Control Platform or guarantee that your information on the platform may not be accessed, disclosed, altered, or destroyed by a breach of any of our physical, technical, or managerial safeguards.

We will store your data for as long as we need it while you are still registered on the platform. If you choose to delete your account, we will remove the data within 60 days.
